Nothing tells you more about the spirit and culture of a country than its cuisine. Georgian national dishes are amongst the best in the world for their diversity and taste.


While meat plays an important part in Georgian cuisine, very close attention is also paid to the locally produced vegetables, fruit and greens.

 to grant Georgian citizenship, including
 Georgian citizenship by exception.



Existing Georgian citizenship law provides for the acquisition of Georgian citizenship by exception to any applicant that makes an investment that is considered a "substantial contribution" to the Georgian state. The goals of the Investment into the Project are to be considered a

VISA-FREE TRAVEL TO SCHENGEN ZONE COUNTRIES

Since 2017, Georgian citizens can travel to the Schengen zone (European countries) visa-free for 90 days. As of October 17, 2020, Georgian citizens had visa-free or visa on arrival access to 116 countries and territories, ranking the Georgian passport 48th in terms of travel freedom according to the Henley Passport Index.



ASSOCIATION AGREEMENT WITH EU

Georgians are not yet eligible to live and work in the EU- this may be possible in the future if and when Georgia applies for full EU membership. Georgia would be eligible for full EU membership since the Association Agreement it signed with the EU establishes that it is geographically included in the Euro zone.







TREATY OF COMMERCE AND NAVIGATION WITH THE UNITED STATES

Georgia has a Treaty of Commerce and Navigation with the United States, which allows Georgians to apply for the E non- immigrant visa.


The E visa requires a small investment of approximately \$100,000 that allows the investor and family to relocate to the US to operate that business. The spouse is permitted to obtain a full work permit and children can attend public school at no charge through the end of high school. Only countries with these eligible treaties qualify for the E visa.

TREATY OF COMMERCE AND NAVIGATION WITH THE UNITED STATES

The following citizens from these countries are not eligible for the E-2 visa: Algeria & Sierra Leone, Angola, Belarus, Brazil, Chad, China, Dem Rep of Congo, Gabon, India, Indonesia, Iran, Iraq, Kenya, Kuwait, Lebanon, Libya, Malaysia, Niger, Nigeria, Peru, Russia, S.Africa, Saudi Arabia, Syria, United Arab Emirates, Uruguay, Uzbekistan, Venezuela, Vietnam, Yemen, Zimbabwe.

Any citizen from the above-listed countries would, once having acquired Georgian citizenship, qualify for the E-2 visa of the Unites States.





Taxpayers in Georgia are subject to the following flat tax rates (modules):

- No corporate income tax on retained and reinvested profit; profit tax applies only to distributed earnings.
- Personal income tax for interest, dividend and royalty is 5%.
- Nocapital gains, wealth or inheritance tax.
 - Pension contribution 2% paid by employer, 2% paid by employee, 2% paid by Government.
 - Double Taxation Avoidance Treaties with 56 countries.





PROCESS


- CitizenGE.org has the authority to assist interested persons (via his/her authorized Agent/Representative) who makes an investment of a minimum of US\$135,000 (single applicant) plus US\$7,500 per eligible dependent (lawful spouse and children up to the age of eighteen (18) years). Additionally, the Applicant will be required to pay processing and legal fees. Consult with your Agent for current charges.
- The investment has been defined as «substantial» and will be utilized to fund specific projects that are considered to be beneficial and a substantial contribution to the state economy.
- Each adult applicant will undergo a stringent background clearance review as part of the application process, including the source of their funds.
- Certain applicants, to be identified at the sole discretion of CitizenGE.org, may be required to undergo «enhanced due diligence», including related to prior employment, public governmental service, and/or source and origin of funds, prior to the application advancing to final review.

CITIZENSHIP BY INVESTMENT

PROCESS

- It is expected that the citizenship processing time will not exceed 120 days, including the issuance of the approved citizenship and passport.
- An applicant may elect to commence the application process by making a deposit of \$8,500 for the purpose of initiating the background clearance. Once this report is issued, the Applicant can elect to withdraw his/her application. If the Applicant proceeds, he/she shall make full payment pursuant to the Citizenship application agreement.
- Funds are held in escrow while the citizenship application is pending. Each applicant will be required, at the start of the process, to transmit by wire transfer the investment amount (plus processing & other fees) to the Escrow account pursuant to an executed escrow agreement. The investment funds are to be held in escrow until such time as Georgian citizenship has been approved in written form.
- Each applicant will be required to obtain and submit/upload the following documents: photograph (passport style), unexpired passport (all pages), birth certificate, marriage certificate, prior divorce(s); record of adoption if applicable.

Qualified agents should submit an inquiry via the website and will receive a response within 24 hours. Agents earn generous commissions that are paid in US funds once the Georgian citizenship application has been approved.

Once the Agent Agreement has been signed, the Agent will have access to the CRM, which is how an applicant's information is uploaded and where all applications are processed and monitored. The Agent will be responsible for collecting and uploading all required information including certified translations and apostle for each required document.
